Rules and Regulations

Carter Plantation Play Pass Holders must comply with the Club Rules, as the same may be amended from time-to-time. The management of Carter Plantation reserves the right to revoke any membership if a member violates any of the Golf Club Rules or Regulations.

To enhance the golf experience and safety of all persons and guests at Carter Plantation ("the Golf Club"), the following rules and regulations ("Club Rules") shall govern the actions and conduct of all members and their guests at the Golf Club.

Use of Facilities

Each Play Pass Holder is entitled to use and enjoyment of the Golf Club, subject to the terms and restrictions of the applicable plan, these Club Rules, and such other restrictions or limitations as may be imposed from time-to-time by management. All modifications to rules will be appropriately distributed to members in writing.

Play Pass Holders must check-in with the Pro Shop before play and agree to abide by all course rules before a cart may be Issued.

Failure to check-in with the Pro Shop may result in a loss of Plan.

Carter Plantation reserves the right to host special events and golf tournaments. Such events may partially or completely restrict the availability of golf course starting times and any or all Golf Club facilities, including, but not limited to use of the clubhouse ("Carter Bar and Grill"), practice range, and the golf course itself. The Golf Club shall have no liability for the temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions, or any and all other matters beyond the control of the Golf Club.

The management of the Golf Club is free to modify the features of the facilities, including but not limited to the relocation of operations, the implementation or cessation of services, the privatization of 18 holes, or such other adjustments or changes as management, in its discretion, deems appropriate.

Pace of Play

Players are to keep at a fair pace with the group in front of them and/or to complete 18 holes in four hours and thirty minutes, whichever is less.

Dress Code

All Players must wear soft spikes. Proper golf attire is required. Denim, cut-off shorts, gym shorts, tank tops, halter-tops, swimwear, and shorts more than 6" above the knee are not allowed on the golf course or in the clubhouse at any time.

Reservation Policies

The Play Pass Holder shall make prior reservations for tee times according to the applicable plan. Starting times that are not cancelled at least 24 hours in advance of play are in violation of our No Show Policy. After your third violation, consequences could be any of the following, which is at the Club's discretion: The Play Pass Holder could lose the right to book premium tee times for a length of time, charged a \$35 No Show fee for Plan Holders, charged a full public rate for all unused tee times, or Carter Plantation could cancel a Plan outright.

In the case of personal emergency, please communicate with Carter Plantation so we do not count your missed tee time as a contract violation. Leniency will be shown for inclimate weather and acts of god. Cart Path Only does not fall under this unless medical issues affect your play. Please communicate with the Pro Shop.

All Players must check in at the Pro Shop at least fifteen (15) minutes prior to a reserved starting time. Failure to do so may result in a cancellation or delay of the tee time if other parties are prepared to play or on standby.

Play Pass Holder is responsible for all the players in the reservation and will be subject to violation fees at Carter Plantation's discretion.

Transfers and Revocation

Plan privileges are personal to the Plan Holder and may not be sold, transferred, or otherwise assigned in any manner. The management of Carter Plantation may revoke any Plan without notice if a member violates any terms of the Plan, general policies of Carter Plantation, and/or these Club Rules, as the same may be hereafter modified. No portion of any fees paid is refundable upon revocation. Club Rules may change from time to time at the discretion of management. All Plans expire on December 31st, and Carter Plantation is not obligated to continue any plans or programs beyond such stated term. A new application for a Plan must be completed and approved for continued membership beyond the stated term.

In the event of a sale or other transfer of Carter Plantation, all Plans shall be honored through the effective date.

Plan Holder shall provide his or her reasonable cooperation in connection with any such matters.

Use of Golf Carts

Golf carts are to be driven in accordance with applicable cart restrictions at all times, and otherwise in a safe and controlled manner. Golf carts are allowed on the fairways of all par 4s and 5s at a 90° angle from the ball to the cart path. However, inclement weather or other conditions may evoke further cart restrictions. The staff will notify players of any temporary restrictions, but players are expected to refrain from driving golf carts where it may damage the golf course. Approved privately owned golf carts are allowed. Play Pass Holders agree they are not to drive as singles in golf carts, they must double up with their guests or other Pass Holders playing in the foursome. No more than two carts per foursome are allowed. No more than two riders and two golf bags per cart. Must be 16 years or older with a valid license to drive a cart. Minors must be accompanied by an adult.

Payment of Fees and Charges

Plan fees are due and payable at the time the Plan's term begins as specified in the Application and/or the first day of every month for twelve months if paying monthly. Plan Holders who are paying monthly will be subject to a \$12.50 administrative fee. All Plan fees are non-refundable, requests to put a membership on hold must be submitted in writing or by Email to (golf@carterplantation.com) where the Golf Course may grant or deny any requests based off the information provided.

Indemnification for Damage

Member shall be responsible for all damages and costs associated with damages as well as personal injury caused by the Plan Holder, the Plan Holder's family, or any guest of the Plan Holder and the Plan Holder shall indemnify, defend, and hold harmless the Golf Club against any claims.

General Limitations

Carter Plantation shall have no liability for the physical damage, theft, or loss to any personal property of Plan Holder or Plan Holder's guests in any way arising from the use of Carter's facilities, to the greatest extent allowed by law.

General Code of Conduct

While at any Carter Plantation facilities, Plan Holder shall conduct himself or herself in a manner that is not abusive, combative or disruptive to other players or staff.

Carter Plantation Management

The Golf Club is administered by the management of the Golf Club. The management is free to run the club in accordance with its discretion. A Play Pass or Social Membership at Carter provides the Plan Holder with certain privileges to use but does not grant the Plan Holder any ownership interest at Carter, or any input into the management of the Golf Course.
